

### A. Membership requirement

The apartment owner must be a personal member of Leukerbad Tourism in order to be included in our holiday apartment publication and renting out system.

**Personal membership fee** CHF 100.00 per year

### B. Registration form for holiday apartments

Registration of basic apartment information and photos in the Leukerbad Tourism reservation system. Please deliver us your pictures. We put them in the system for free.

### C. Classification questionnaire (STF Holiday apartment classification)

Classification of the apartment, according to the Swiss Tourism Federation (STF).

**Classification of a holiday apartment** (Current validity classification period: 2013 - 2017)

**CHF 60.00 per holiday apartment / per classification period (plus VAT)**

### D. Contract for direct booking through Leukerbad Tourism and online bookings

Optimise the occupancy of the holiday apartment by putting into the online booking system of Leukerbad Tourism (Only possible if conditions A - C are fulfilled).  
Special conditions for this direct booking do apply. (Details of direct booking terms can be obtained from Leukerbad Tourism.)

### E. Cost contribution for publication as under point A – D described

### F. Tourism promotion tax (obligatory for all rented holiday apartments)

**The proprietors of rented holiday apartments pay the following flat-rate amounts annually:**

a) per 1- to 1 ½- room apartment	CHF	195.00
b) per 2- to 2 ½- room apartment	CHF	260.00
c) per 3- to 3 ½- room apartment	CHF	310.00
d) per 4- room apartment and above	CHF	360.00

### G. Tourist tax approaches for apartments (including Leukerbad Card Plus) for the municipalities Leukerbad, Albinen, Inden and Varen

Adults	CHF	6.00 per night
Children aged 6-16 years	CHF	3.00 per night
Children under 6 years	tax-free	

For commercially let holiday apartments, the owners/hosts collect tourist taxes from their guests as hitherto on the basis of actual overnight stays (effective rate). They enter guests in the electronic registration system via the registration client. Upon registration, a personalised Leukerbad Card Plus is generated for each guest. The owner/host provides the guests with their cards for use throughout the duration of their stay.
